**CROSS CONNECTIONS
VILLAGE OF SHEPHERD, MICHIGAN
ord. eff. Mar. 15, 1979**

An ordinance to regulate cross connections with the public water supply system, i.e., a connection or arrangement of piping or appurtenances through which water of questionable quality, waste or other contaminants can enter the public water supply system.

THE VILLAGE OF SHEPHERD ORDAINS:

Sec. 1. CROSS CONNECTION RULES ADOPTED.

That the Village of Shepherd adopts by reference the Water Supply Cross Connection Rules of the Michigan Department of Public Health being R 325.431 to R 325.440 of the Michigan Administrative Code.

Sec. 2. INSPECTIONS.

That it shall be the duty of the Village Water Department to cause inspections to be made of all properties served by the public water supply where cross connections with the public water supply is deemed possible. The frequency of inspections and reinspections based on potential health hazards involved shall be as established by the Village Water Department and as approved by the Michigan Department of Public Health.

Sec. 3. RIGHT OF ACCESS, INFORMATION.

That the representative of the Village Water Department shall have the right to enter at any reasonable time any property served by a connection to the public water supply system of the Village for the purpose of inspecting the piping system or systems thereof for cross connections. On request the owner, lessees or occupants of any property so served shall furnish to the inspection agency any pertinent information regarding the piping system or systems on such property. The refusal of such information or refusal of access, when requested, shall be deemed evidence of the presence of cross connections.

Sec. 4. DISCONTINUING SERVICE.

That the Village Water Department is hereby authorized and directed to discontinue water service after reasonable notice to any property wherein any connection in violation of this ordinance exists, and to take such other precautionary measures deemed necessary to eliminate any danger of contamination of the public water supply system. Water service to such property shall not be restored until the cross connection has been eliminated in compliance with the provisions of this ordinance.

Sec. 5. LABELING UNSAFE WATER.

That the potable water supply made available on the properties served by the public water supply shall be protected from possible contamination as specified by this ordinance and by the state and village plumbing code. Any water outlet which could be used for potable or

domestic purposes and which is not supplied by the potable water system must be labeled in a conspicuous manner as:

**WATER UNSAFE
FOR DRINKING**

**25.156 Sec. 6. RELATIONSHIP OF ORDINANCE TO
PLUMBING CODE.**

That this ordinance does not supersede the state plumbing code or any present or future village plumbing ordinance but is supplementary to them.

25.157 Sec. 7. PENALTY.

That any person or customer found guilty of violating any of the provisions of this ordinance, or any written order of the Village Water Department, in pursuance thereof, shall be deemed guilty of a misdemeanor and upon conviction thereof shall be punished by a fine of not less than \$15.00 nor more than \$100.00 for each violation. Each day upon which a violation of the provisions of this act shall occur shall be deemed a separate and additional violation for the purpose of this ordinance.

25.158 EFFECTIVE DATE.

This ordinance shall take effect ten (10) days after its final passage by the Village Council of said Village of Shepherd.
